- Arguing that the rescission of Deferred Action for Childhood Arrivals was arbitrary and capricious and thus unlawful in Department of Homeland Security v. Regents of the University of California; and
- Arguing the unconstitutionality of overly vague federal criminal laws inMcDonnell v. United States.
