

He has served as an expert in ethics and related issues on numerous occasions.

Prior to private practice, Tom worked for the Federal Public Defender for the District of Maryland, where he represented clients in a wide variety of cases, including espionage, civil rights, mail and wire fraud, and controlled substance prosecutions. He went on to join the Public Defender Service for the District of Columbia, where he had an intensive criminal trial and appellate practice.

Tom is a member of the D.C. Bar Innovations in Legal Practice Committee and a past member of the American Bar Association Standing Committee on Ethics and Professional Responsibility. Tom served on the D.C. Bar Legal Ethics Committee from 2006 to 2012, including three terms as Chair from 2009 to 2012. Tom also served on the D.C. Bar Rules of Professional Conduct Review Committee from 2002 to 2008 and from 2013 to 2020, including terms as Vice-Chair and Chair. During his tenure, the Committee adopted the most extensive revisions to the D.C. Rules of Professional Conduct since the D.C. Bar adopted the Rules in 1991.

Tom speaks and writes frequently on ethics and malpractice matters. He is a regular speaker at the D.C. Bar and has also spoken before various sections of the American Bar Association, the Practising Law Institute, the American Law Institute, and a number of other bar and industry organizations. Tom consistently earns praise for the caliber of his presentations, particularly his thorough examination of nuanced topics and detailed knowledge of the subject matters he addresses. He has written on topics such as non-lawyer partners and multiple "of counsel" relationships with different law firms. Tom taught ethics and professional responsibility at Georgetown Law from 2008 to 2016 and has taught various subjects at the National Institute for Trial Advocacy, The Catholic University of America Columbus School of Law, and American University Washington College of Law.
