He has also represented clients called to testify before House and Senate committees.

Tom founded HWG's litigation practice and served as chair until 2024.

Before joining HWG, Tom served ten years as an Assistant United States Attorney in both the Eastern District of Virginia and the District of Columbia. During his tenure as a prosecutor, Tom was lead trial counsel in more than 50 jury trials in matters involving espionage, homicide, RICO, public corruption, bank fraud, government procurement fraud, export control matters, and immigration fraud.

Tom was awarded both the John Marshall Award, the Department of Justice's highest honor, as well as the Intelligence Medallion, the CIA's highest civilian honor, for his work in the prosecution of James Nicholson, the highest-ranking CIA official ever convicted of espionage. Tom also successfully prosecuted David Sheldon Boone, a National Security Agency (NSA) crypto analyst, for spying on behalf of the Russian Federation.

REPRESENTATIVE EXPERIENCE

- Served as lead counsel in the matter of *Hatfill v. Ashcroft*, a Federal Privacy Act suit brought by Dr. Steven Hatfill against Attorney General John Ashcroft, the U.S. Department of Justice, and the FBI, after a campaign of leaks in the government's investigation of the anthrax attacks. Dr. Hatfill was fully exonerated by the FBI. The government ultimately paid Dr. Hatfill \$5.8 million, one of the largest Privacy Act settlements in history.
- Represented one of the defendants in *S. v. Price, Zaborsky & Ward*, a high-profile obstruction of justice case in the District of Columbia Superior Court. At the conclusion of the two-month trial, the defendant was found not guilty.
